**OFFICIAL RULES**

- 1. SWEEPSTAKES PERIOD:** The Bonne Maman® and SMEG USA (“Sweepstakes”) Starts 3:00 PM ET (“ET”) on November 11<sup>th</sup> 2024 and ends 2:59 PM ET on December 6<sup>th</sup> 2024 (“Sweepstakes Period”). Administrator’s computer is the official time-keeping device for the Sweepstakes.
- 2. ELIGIBILITY:** The Sweepstakes is open only to legal residents of the 50 contiguous U.S. and DC, who are 18 years of age or older at time of Entry (defined below).
